Quantum of penalty - According to the Adjudicating Authority it is 15% of the Service tax amount whereas as per the first appellate authority it has to be 25% - service tax alongwith the interest paid on being pointed out - HELD THAT:- The appellants have all along admitted the tax liability and paid the same with the interest, wherever there is a delay.
